## TWIN FALLS GOLF ADVISORY COMMISSION

August 14, 2013

### STAFF REPORT

**1. Approve minutes of the July 10<sup>th</sup> 2013 meeting.**

The Commission needs to approve or amend the proposed set of minutes.

**2. Fund Raising Golf Tournament Update - Staff and Commission**

Attached is the latest revenue/expenditure spreadsheet from the 2013 golf tournament. As of 8-8-13, the gross revenue for the tournament is \$8,587, as you can see from the spreadsheet, including the remaining balance forward from last year's tournament; we have almost \$7,500 for project this coming year.

The Commission has advertised that bunkers, tee boxes, and cart paths will be improved from the revenue of this year's tournament. We have moved the meeting location this month to the Twin Falls Golf Club, so the Commission can pinpoint the cart paths, the bunkers, and tee boxes that will get improved.

**3. Long Term Goals Discussion**

Staff research old Golf Advisory Commission minutes and found a couple of instances of where the Commission developed a priority list for the golf course. These were from 1997. They are listed in order of the Commission priority:

1) Sprinkler system; 2) Tee Boxes – Ladies # 1 & 15, Men - # 10 & 12; 3) Fencing along #12, and #17 and some at #6; 4) Cart Paths; 5) Equipment for the golf course; 6) Green # 16; 7) Sand traps around greens and fairway bunkers; 8) Roof for Shed; 9) A nursery; and 10) Parking Lot.

Some items that the Commission should discuss for long term goals are: Greens, tees, bunkers, irrigation system, trees, drinking fountains, clubhouse, the old maintenance building, equipment, overflow parking area.

One of the eight focus areas for the City's Strategic Plan is the Healthy Community, under this focus area, one of the initiative is: The City will provide programs and services that support healthy lifestyles. There are two objectives under this initiative that the golf course could focus on. There are: 1) Provide affordable healthy lifestyle

programs for kids; and 2) Reduce health risks through expansion of physical activity programs provided by the City and/or in partnership with others.

The Commission can develop long terms goals for the golf course that deals with the course itself, the clubhouse, maintenance shop, equipment, etc. Also the Commission should develop some goals that tie into the City's strategic plan especially with those two objectives under the Healthy Community focus area.

Staff proposed for the Commission to form a sub-committee to develop a draft of long term goals for the course and bring them back to the full Commission for their consideration.
