**Terminal Project**

Airport Manager, Carberry, discussed the contract with CSHQA on the terminal modification. The city and county both approved the contract for Phase 1, terminal assessment and concept plans. The Architect, Engineers, Airport Personnel, Airline, City Info Services Director and TSA met and discussed initial planning issues between all the groups.

**Air Service Update**

Airport Manager, Carberry discussed his visit to SkyWest Airlines at their headquarters in St. George, Utah, March 11-12, 2014. Accompanying him were Dan Olmstead, Jan Rogers, and Shawn Barigar. The group went to discuss future plans, performance of the Twin Falls market, and a general discussion regarding the state of the industry. They discussed the airlines decision to transition from 30 seat Brasilia turbo props to 50 seat regional jets beginning on June 6, 2014.

**Air Magic Valley**


