MINUTES

Vice-Chairperson Jack Jardine called the meeting to order at 11:05 am.

Item # 1 Approve minutes of the July 9, 2014 meeting
Jack Jardine motioned to approve the meeting minutes and Brett Semple seconded the motion. Motion passed with a unanimous vote.

Item #2 “Friends of Muni” Fundraising Tournament
Dennis indicated that there were thirty teams in the tournament this year. We did not gross over \$10,000. Dennis went over the financial spreadsheet for the tournament. The gross revenue was \$9355 and with the holdover from last year

we have a little over \$10,000 to do projects this year. Travis indicated that although there were seven Hiskey teams revenue from them was only in the form of the team entry fee. Teena asked if a spreadsheet could be done to separate funds into the categories so that the areas needing improvement can be identified. Travis indicated he could do that. She also asked for a list of the teams and what they paid for, did they just pay to play or did they sponsor a hole. Discussion on how the raffle items can be improved. Dennis will wait for a few days to see if any more funds come in and then he will call the Hiskey's and let them know that we did not exceed the \$10,000 mark and there will be no funds to distribute to them. Discussion on what we could do about the memorial area and it was decided that we should fix up the water fountain.

Brett indicated that thank you letters will need to go out to those who donated to the tournament. Everyone should send a list to Nikki so she can send out thank you letters.

There was discussion on what to do with the funds from the tournament. Dennis displayed a visual for some areas of concern at the golf course especially around number 10 cart path. Dario did some measurements out there and many times large equipment has to access it so that portion of the cart trail needs to be ten feet wide. The cost to widen that path would be \$4800 dollars for a 193 linear feet. Also on number 9 tee box which is kind of torn up, to fix it would be another \$2500. It is up to the Commission to decide what to do with the funds. Jack said it would be visible for all to see the improvement. Rich asked if we could table this and ask members what they might like to see. Travis and Steve had talked about splitting the funds up in different areas of the course. The runway on number 9 is rough and maybe fix with a shoot like we have on number 6, and one other tee box we thought could use some work. Also, number 7 tee box maybe redoing that one as it is probably the next one on the list. Brett mentioned that people might want to have better sand or hit off a better fairway than drive on concrete. Maybe there is some other way to smooth off number 9. The other runway in need of work is number 5. Rich said that if it is muddy and he gets out of the cart then his shoes get muddy and if we had perhaps just a concrete pad to pull onto next to the tee box so we don't get all muddy might be an idea.

Item #3 Other Item from the Commission

Meeting adjourned at 11:35 am.
