### STAFF REPORT

**1. Welcome New Commission Member – Staff and Commission**

The City Council approved Helen Brown to serve on the Commission as the representative from the Women's Golf Association. Also the Council re-appointed Brett Semple and Rich Birrell to the Commission.

With Lance Clow resigning from the City Council, the Golf Advisory Commission lost its liaison to the City Council. At this time, his replacement has not been appointed.

**3. Election of Officers – Staff and Commission**
