1 Repair and improve number 7 tee box. (\$1,000)

2 Repair and improve number 14 blue tee box. (\$1,000)

3 Purchase 4 more outdoor driving range mats. (\$900)

4 Add a fairway bunker to the right side of the fairway on hole number 16. (\$2,500 ?)

5 Construct a doorway in restaurant bar area that leads to a new patio deck area on the north east corner of the building. Purchase tables, chairs, and umbrellas for the deck. Early cost estimates would be around \$5,000.

6 Continue with concrete paths around the club house.
